5. Add up the Grand Total and enter it at the bottom right corner of this Form.

*If a sponsor pays a fixed amount, put that amount in the (right hand) Total column.*

Mail/take the completed Form and Grand Total \$ amount to your Court Secretary by **April 1, 2008**.

If you give the Grand Total as a check, make it to your Court, (*add **Diabetes Walk** in left corner*).
